Eligibility for unemployment insurance, benefit amounts and the length of time benefits are available are determined by the state law under which unemployment insurance claims are established. In the majority of states, benefit funding is based solely on a tax imposed on employers. (Three states require minimal employee contributions.)

Unlike individual insurance, where employees pay separately for 100 percent of their own premiums, group insurance allows employers and employees to share the costs, with employers covering some part of the premium cost for a single employee or dependents.

Federal Employees Group Life Insurance

The cost of employer-provided group-term life insurance on the life of an employee's spouse or dependent, paid by the employer, is not taxable to the employee if the face amount of the coverage does not exceed \$2,000. This coverage is excluded as a de minimis fringe benefit.
